# UNITED KINGDOM AND ARGENTINA AGREE JOINT STATEMENT ON AREAS OF MUTUAL COOPERATION

As per Foreign & Commonwealth Office and The Rt Hon Sir Alan Duncan MP on 14th September 2016 the British Government and the Government of Argentina have agreed to an improved relationship through closer co-operation on areas of mutual interest, including on trade and security.

A UK-Argentine joint statement has been agreed following a series of high level meetings in Buenos Aires with Sir Alan Duncan - the first Foreign Office Minister to visit Argentina since 2009.

During the visit both countries agreed the first positive statement on South Atlantic issues since 1999, which set out a commitment to work together on issues affecting the South Atlantic and the Falkland Islands. They agreed to work toward removing restrictive measures around the oil and gas industry, shipping and fishing affecting the Falkland Islands in the coming months. Both delegations expressed support for a project to identify
